For Nov. 2, the League recommends . . .

Following are the positions of the League of Women Voters of California regarding propositions in the November 2 Statewide General Election:

Prop 19 – Legalize and Regulate Marijuana – No Position

Prop 20 – Redistricting of Congressional Districts – Oppose - Well-intentioned but premature.

Prop 21 – \$18 Vehicle License Fee for State Parks and Wildlife Programs – Neutral

Prop 22 – State Government Prohibited from Taking Local Funds – Neutral

Prop 23 – Suspends Clean Energy and Air Pollution Standards – Oppose - Funded by out-of-state oil companies, this would suspend the landmark Global Warming Solutions Act of 2006.

Prop 24 – Tax Fairness Act – Support - Would repeal corporate tax cuts passed in closed-door budget deals in 2008-09.

Prop 25 – Simple Majority Vote for Budget – Support

Prop 26 – “Polluter Protection” – Oppose - Redefines regulatory fees as taxes, which require a two-thirds vote for approval.

Prop 27 – Eliminates State Commission on Redistricting – Strongly Oppose - Would kill the major redistricting reform voters just approved in 2008.

LWVC and LWV San Joaquin County strongly support single-payer health care, most recently considered by the legislature as SB 810 (Leno), the California Universal Health Care Act. The bill was held on the Assembly floor on the last night of the 2010 legislative session, effectively killing the measure until next year.

Program on health of the Calaveras River

In "Water for us all?" Dr. Stacy Luthy will discuss the health of our drinking water sources and the condition of the Calaveras River and local fish resources. Dr. Luthy studies growth and habitat usage of young fishes in habitats ranging from the Gulf Stream to salt marshes to freshwater sounds.

The event will take place at UOP beginning at 6 PM on Monday, October 4, with Dr. Luthy's presentation in the Barbara Bechtel Davies Lecture Hall in the Biological Sciences Center, followed by a reception in the lobby.
